 Computershare Pvt Ltd, Hyderabad for minimum of Rs 500/- for
 One certificate or upto Rs 1000/- for 5 share certificates or in multiple of 5 certificates for every 5 certificates.
 - Affidavit must be Notarized except Foreign Shareholders
- b) Send an intimation for loss of shares to Stock Exchanges
- c) Publish advertisement in News Paper for loss of shares with 15 days Notice period to the public for valid cases format enclosed.
- d) Process request for Issue of duplicate certificate within 30 days from the receipt of documents.
